## Description

A By-law of the Municipal Corporation of the Hamlet of Cambridge Bay in the Nunavut Territory to appoint a By-law Officer, pursuant to the provisions of the Hamlets Act, R.S.N.W.T., 1988, C.H.-1, S. 171.

## By-Law

Hamlet of Cambridge Bay desires to enforce the By-laws of the Hamlet;

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF CAMBRIDGE BAY, at a duly assembled meeting enacts as follows:

1. Dave Taylor is hereby appointed as a By-law Officer of the Hamlet of Cambridge Bay with authority to issue written or spoken orders to ensure compliance with the By-laws of the Hamlet.
2. The duties and powers of the By-law Officer shall be described in Schedule A attached to and forming part of this By-law.
3. By-law #161 appointing Michael Butt as a By-law Officer is hereby repealed.

### **BY-LAW No. 189 – Schedule A**

#### **APPOINT BY-LAW OFFICER**

Under the direction of the Senior Administrative Officer, the duties and powers of the By-law Officer shall be as follows:

- a) encourage and ensure due observance of the provisions of the By-laws of the Hamlet;
- b) assist in the administration of the provisions of the By-laws of the Hamlet;
- c) conduct patrols, investigations and enquires of the Hamlet with respect to the Hamlets By-laws;
- d) complete daily shift reports
- e) report to Council as required;
- f) prepare monthly summary reports
- g) perform such duties as may from time to time be designated by the Senior Administrative Officer;
- h) Represent the Hamlet in the prosecution of any person charged with contravening a Hamlet By-law.

#### OATH OF BY-LAW ENFORCEMENT OFFICER
