Description

A By-law of the Municipal Corporation of the Hamlet of Cambridge Bay in the Nunavut Territory to delegate the By-law Officer, pursuant to the provisions of the Hamlets Act, R.S.N.W.T., 1988, C.H.-1, s.171.

By-Law

As the Hamlet of Cambridge Bay desires to delegate the By-law Officers of the Hamlet of Cambridge bay to the Royal Canadian Mounted Police (RCMP);

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF CAMBRIDGE BAY, at a duly assembled meeting enacts as follows:

1. The Royal Canadian Mounted Police (RCMP) with support of their Senior Administrative Officer is hereby appointed supervisors of the Cambridge Bay By-law Enforcement Department.
2. The duties and powers of the RCMP as it pertains to the supervision of the Cambridge Bay By-law Enforcement Department shall be described in Schedule "A" attached to and forming part of this By-law.

BY-LAW No. 182 – Schedule A

DELEGATE BY-LAW OFFICER

Under the direction of the Senior RCMP Officer and support of the Senior Administrative Officer, the duties and powers of the By-Law Enforcement Department shall be as follows:

- (a) The Senior RCMP Officer will schedule all shifts of the Cambridge Bay By-Law Enforcement Department (By-Law Officers);
- (b) Under the supervision of the Senior RCMP Officer, the By-Law Officers will conduct patrols, investigations and enquires of the Hamlet with respect to the Hamlets By-laws;
- (c) The Senior RCMP Officer will be responsible for the supervision, discipline and recruiting By-law officers with the assistance of the Senior Administrative Officer;
- (d) The By-law Officers will make all required reports to the Senior RCMP Officer;
- (e) The Senior RCMP Officer will make these reports part of their monthly report to Council;
- (f) Perform such duties as may from time to time be designated by the Senior Administrative Officer and the Senior RCMP Officer;
- (g) Represent the Hamlet in the prosecution of any person charged with contravening a Hamlet By-law.
