Description

A By-law of the Municipal Corporation of the Hamlet of Cambridge Bay in the Nunavut Territory to acquire vehicles pursuant to the provisions of the Hamlet Act, R.S.N.W.T., 1988, c. H-1, s. 132.2

By-Law

As the Council of the Hamlet of Cambridge Bay deems it to be in the public interest to acquire the vehicle described hereunder;

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF CAMBRIDGE BAY, at a duly assembled meeting, enacts as follows:

1. That the Mayor and Senior Administrative Officer are hereby authorized on behalf of the Hamlet of Cambridge Bay to lease from Kingland Ford the vehicles listed in Schedule "A".
2. That the said vehicles shall be acquired for municipal purposes.
