Description

A By-law of the Municipal Corporation of the Hamlet of Cambridge Bay in the Northwest Territories to acquire real property pursuant to the provisions of the Hamlets Act, R.S.N.W.T., 1988 c. H-1, s. 132.2.

By-Law

As the Council of the Hamlet of Cambridge Bay deems it to be in the public interest to acquire the land described hereunder;

Now, therefore, the council of the Hamlet of Cambridge Bay, at a duly assembled meeting, enacts as follows:

1. That the Mayor and the Senior Administrative Officer are hereby authorized on behalf of the Hamlet of Cambridge Bay to purchase from the Commissioner of the Northwest Territories for the sum of One Dollar (\$1.00). receipt of which is hereby acknowledged, the land described in Schedule "A" and the buildings described in Attachment "B" attached to and forming part of this By-Law.

2. That the said land and buildings shall be acquired for municipal purposes.
