Description

A by-law of the Municipal Corporation of the Hamlet of Cambridge Bay in the Northwest Territories to acquire real property pursuant to the provisions of the Hamlets Act, R.S.N.W.T, 1988 c. H-1, s. 132.2 .

By-Law

As the Council of the Hamlet of Cambridge Bay deems it to be in the public interest to acquire the land described hereunder;

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF CAMBRIDGE BAY, at a duly assembled meeting, enacts as follows:

1. That the Mayor and the Senior Administrative Officer are hereby authorized on behalf of the Hamlet of Cambridge Bay to purchase from the Commissioner of the Northwest Territories for the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, the land described as the whole of Lot 24, Block 16, Plan 2754 in the Hamlet of Cambridge Bay.

2. That the said land shall be acquired for municipal purposes.

Nursing Station Area , Cambridge Bay

By-law 125 is required as we had errored in by-law 113. The plan of survey for lot 24, Block 16 read as 2574 when it should have read 2754. Land Titles Office confirmed with me that a new by-law must be prepared. I requested we prepare a statutory declaration stating there was a typing error, however, they would not allow this. This has created a problem with the sale of the nursing residence. By-laws 123 and 124 are being presented for 3rd reading this Thursday July 16, to take on the roads and road names of the design. **The sale will not go through unless we have 3 readings for by-law 125 too.
