## Description

A By-law of the Hamlet of Cambridge Bay in the Nunavut Territories to adopt a Municipal Crest and/or Flag, subject to the approval of the Minister, pursuant to the provisions of the Hamlets Act, R.S.N.W.T., 1988, c. H-1, s. 128.

## By-Law

As the Hamlet of Cambridge Bay desires to adopt and regulate the use of a municipal crest and flag for the Municipal Corporation;

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF CAMBRIDGE BAY, at a duly assembled meeting, enacts as follows;

1. **Short Title**

This By-Law may be sited as the *Community Crest / Flag By-Law*.

2. **General Provisions**

The design depicted in Schedule 1, attached to and forming part of this by-law, is adopted as the Municipal Crest and Flag of the Hamlet of Cambridge Bay.

3. No person other than the Hamlet of Cambridge Bay shall:

- a) use the municipal crest or flag adopted under this by-law for any purpose, or
- b) sell or otherwise dispose of any item for profit containing the municipal crest and/or flag,

Without having first obtained from the Hamlet a permit to do so, in the form shown in Schedule 2, attached to and forming part of this by-law, on such terms and conditions as the Council may determine.

4. **Penalty**

Every person or business who contravenes section 3 of this By-law is guilty of an offence and liable on summary conviction to a fine of not less than \$50 and not more than \$200 or, in default of payment of a fine, to imprisonment for a period not exceeding one month.

5. **Schedule**

Schedules 1 and 2 are attached to and form part of this By-Law.

6. By-law #83 adopting the Hamlet Flag is hereby repealed.
