A By-law of the Municipal Corporation of the Hamlet of Cambridge Bay in the Nunavut Territory to acquire real property, pursuant to the Hamlets Act, R.S.N.W.T. 1988, c.H-1, s. 1 32.2.

## By-Law

WHEREAS THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE HAMLET OF CAMBRIDGE BAY, in a duly assembled meeting, enacts as follows:

1. The Mayor and the Senior Administrative Officer are hereby authorized on behalf of the Hamlet of Cambridge Bay to purchase from the Commissioner of the Northwest Territories for the sum of One Dollar (\$1.00), receipt of which is hereby acknowledged, the land described in Schedule "A", attached to and forming part of this by-law.
  
2. That the said land shall be acquired for municipal purposes.
