The purpose of this exercise is to see if the community of Cambridge Bay can hold up to 1700 more people for up to 72 hours in case of a disaster or an emergency or if there was a cruise ship disaster. This would be the timeframe as to when we would start to move people or start to have relief for the community.

d. University of Ottawa - Natalie

Natalie presented the results of a research project that has involved various organizations in Cambridge Bay regarding the Northwest Passage. There was collaboration with the university and locals, who were recommended by the HTO. Culturally significant marine areas and the recommendations of the low impact shipping areas were discussed and mapped. We are here presenting and validating our results with the community. The project is a research project about the low impact shipping corridors that are proposed by the federal government as routes that ships can take thought the Canadian high arctic that would pose less risk to communities and minimize potential disaster environmental challenges. Part of the project was to have the northerner's knowledge, Inuit knowledge and also to have your feedback. There are a number of concerns that were brought to our
