b. Lotteries

ASAO MacEachern - We have received the 2016 Nunavut Lotteries Statement and there are a few items to highlight. On page 4 it shows how much was transferred to Sport Nunavut from the sales of tickets. There is the article from CBC in 2013 showing the total sales were \$1.6M and \$100,000 of that went to the Western Lottery Corporation for their operating expenses and \$500,000 went to Sport Nunavut. Also, in the package, there is information from NWT Lotteries and where the funds go to. Annually there is about \$4M that goes back to Nunavut and the NWT to programs. There is also information regarding gambling addictions.

Councillor Taipana asked for clarification as to what is being sold at the terminal.

ASAO MacEachern They would be selling the 649 tickets, they would not be selling the Nevada's as the bingo groups do this. I have spoken with the SAO in Arviat and he said that since opening their terminal it has had a negligible impact on their fundraising efforts.

Council discussed and are in favor of the lotteries terminal.

The issue was when the water tank and sewage tank were removed they found mold in the entire flooring and had to have that remediated before any work was done for the interior. Since then the new cabinets and flooring is going in. We have everything here and all we are waiting on are the doors and window installation.
