### 10. Management Reports

#### **SAO Limousin**

#### a. Tiny Home Approval

Approval and funding will be granted to explore the concept and design of a northern Tiny Home Development to create affordable private housing. We will bring to Committee to determine how we will create the project and who we will partner with.

#### b. Radio Station in Double Portable

Because of the tight time lines for the renovation to the Homeless Shelter and the need to immediately move the Radio Society out, would it be OK to put them in the other side of the Double Portable as is nearly ready and move the Thrift shop to a renovated S&R building?

Discussion took place about this. It seems like they have not tried to find their own place and we are left trying to accommodate them. They are an independent Society and yes they are an important community function. They will need to pay economic rent as they fund raise and make money. We cannot afford to subsidize them as it appears we have been doing at the existing building. Council suggested that they pay \$1,000 per month and that it should only be temporary.

#### c. Thrift Shop in S7R Building

Looking at alternative places for a Thrift Shop that could make money to offset the cost of the Food Bank as there is no funding for food banks.

#### d. MLA Ehaloak will be in town for July meeting

The Proposals have been rated and evaluated using the evaluation criteria that was established and distributed with the tender package. After review of the tenders, Qillaq offered the best price for the project with skilled operators and meeting the completion schedule prior to freeze up. Recommendation is to award the contract to Qillaq Innovations. Qillaq Innovations had provided two prices, one with rock trucks and one without. The price difference was not significant but the wear and tear on the vehicles is.
