- a. RCMP Update Sgt. Jean-Guy Lalonde (November, December and January updates)
 - -Councillor Wilcox would like to see programs like anger management workshops.
 - -Sgt. Guy Lalonde would like to see mental health patients flown out of the community for treatment, some residents choose not to participate and/or drop out of the programs offered locally.
 - -Councillor Wilcox would like to see more close ties and programs with interagencies.

- -Sgt. Guy Lalonde promotes the programs, and encourages residents to participate, but they self-medicate through alcohol and drugs, some are fine until payday. Friday and Saturday, they are busy; however, Sunday's are the busiest day.
- -Councillor Jancke, how many RCMP officers are in town?
- -Sgt. Guy Lalonde, we are full staff since October
- -Councillor Jancke, how are people who are in situations dealt with?
- -Sgt. Guy Lalonde, under the mental health act; we can take the person to the mental health to be examined, and we stay until they are 100% sure they are stable. Nine out of 10, when they hurt themselves, they are intoxicated or high on drugs. There is no safe room at the detachment, just a regular cell.
- -Mayor Ehaloak, do you have statistics to show how many times a person is brought in?
- -Sgt. Guy Lalonde, we have a regular list of people who repeatedly come in
- -Councillor Jancke, Chris from NTI did a prime prevention program; we are planning to have a meeting in a couple of weeks for the CPP
- -Sgt. Guy-Lalonde, Chris is the representative for the CPP
- -Councillor Jancke, we want to facilitate a meeting
- Sgt. Guy Lalonde, we make recommendations, we provide a good history, and provide help.
- b. RCMP Sgt. Jean Guy-Lalonde Community Involvement Initiative
- -Sgt Guy Lalonde, on the school side, we attend Friday mornings for the fundraising program and we are trying to connect with the youth. We recently organized a hockey game with the kids, we have visited the day care, and we have gone public skating with the kids in our uniforms. We skate with the kids on our days off as often as possible. We have four RCMP officers who play Senior Hockey, two of our members take the assist suicide training, we have had discussions with the group home and the mental health and we carryout ongoing intelligence gathering for alcohol and drugs. We have had discussions with the by-law officer and meetings with social services to discuss youth crime. Most of these activities are done outside of our working hours, to form a bond with the community.

- -Sgt. Guy Lalonde, next week we will be checking for expired license plates, give warnings for speeding, educate the community with traffic enforcement, we're going to start with verbal warnings, and then written warnings.
 - d. RCMP Sgt. Guy Lalonde Bootlegging Project
 - -Sgt. Guy Lalonde, we are meeting with the liquor inspector to try to slow it down.
 - -Councillor Mulhern, I see large amounts of money being laundered out, by the same group of people, how can I help.
 - -Sgt. Guy Lalonde, crime stoppers
 - e. RCMP Sgt. Guy Lalonde Recreation Crime Prevention
 - -Sgt. Guy Lalonde, we had a meeting with Chris from Iqaluit, he has funding available, which can be used to hire summer students to do a program to keep the kids out of mischief. We suggested hiring mature summer students to run programs. We spoke to many big companies such as Kitnuna and CHARS to cement the floor in the hockey rink. - Mayor Ehaloak, a lot of the community members don't know what the land referendum is about, the information the GN provided didn't seem to answer all of the questions and concerns. I've heard a number of complaints since the Land Referendum meeting about the GN not being neutral they were very biased in their delivery of information. We can hold a couple additional information sessions prior to the May 9th Referendum.
- ASAO MacEachern: I will forward the information we have been provided by the GN and a link

to the GN Land Referendum website before the next meeting.

- Deputy Mayor Ohokannoak, Thank you. Human Rights Tribunal: there is a lack of health being provided to our children, we used to have a dental hygienist at our school, can we pursue that somehow?
- Councillor Mulhern, Let's Talk Science: they have been here a few times, they gave funding to the school, and we just let them know what we want to do with the money. We started an antibullying campaign on the 25th, KSO held the second meeting today. We should push to have these antibullying talks increase.
