Councillor Wiz Mohammed- "is there a reason why the track was not in view of the audience area? There were elders asking about it because they couldn't see what was going on and wanted to enjoy the race."

Councillor Angulalik Pedersen- "I was on the committee and the reason that we did that was because the people who prepared the ice, made it difficult to continue using the ice to get close. The ends weren't flat as there were piles of the ice and we couldn't get the racers to go through safely and they would be closer to the crowd as well, as just past there, the snow was really bad from a lack of snow and very hard to flatten the ice."

Councillor Angulalik Pedersen- "Yes and I wanted to mention as well we lost the PA system half way through the week so it was very hard to get information to the audience."

I noticed that there are Elders in the community that use wheelchairs and walkers so I would like to recommend for next year to create a designated area at these races during Omingmak Frolics with access for the elders and only for the elders so that they are not sitting out by vehicles. It is very nice to see them out enjoying the events and would be nice for them to have front row viewing as well.

Something that has been talked about often is the water that consumes and piles up over the cracks on the ice. There were suggestions from community members to drill some holes for drainage as well as a path for community members to get on to the ice.

Another thing that was brought to my attention was Bylaws, and one in particular was about stores being opened on statutory holidays. Can we control the times and days that stores are open? I have had another inquiry about why the taxi fare rate to CHARS is at a different rate?"

ACAO Jim MacEachern- "The 2015 Taxi Bylaw states that in-town rates are a flat fee of \$7.00 fare and the Airport is \$14.00."
