It was a significant decline in alcohol related activities and the number of people that ended up in the cell. 484 calls compared to 155 call and 116 prisoners compared to 39.

7. Business

a. COVID-19

a. Allocate \$92,600

The CAO advised the Council that the Municipality of Cambridge Bay received \$92,600 from the Government of Nunavut to help with the COVID-19 situation. The Municipality has been running a Food for Soul program which provides nutritious meals to residents from Monday to Friday with a previous grant given to the Municipality for making food available to the community.

With the new monies, requesting input from Council of how to allocate the \$92,600.

Councillor Candice Pedersen: Plow the Mount Pelly Road or do a parade but social distancing.

Councillor Wilfred Wilcox: Continue with the food programs or plow the roads to Mount Pelly or Gravel Pit.

Councillor Derek Elias: Cleaning of the Mount Pelly road or extending the food program.

Councillor Savanna Moore: Goodie bags for different age ranges with activities to do.

Councillor Jenna Kamingoak: Continue on with the food program but add in country food.

Deputy Mayor Angulalik Pedersen: Plow the Mount Pelly road and restocking the HTO freezers. Giving the local hunters some money to go out and catch country food for the community.

b. Cancellation of activities

Information was given on the CPHO's guidelines for self- isolation and social distancing and the fact that it is illegal to gather in groups of 5 or more peoples not form the dame household.

The Omingmak Frolics will be postponed until such time that the community can gather again. The Multi-Cultural Event has been cancelled and some events may be incorporated into something else later in the year. All Cruise Ships, Embrace Life Summit, Youth Summit and many more activities have all been cancelled this year due to COVID-19.

c. Card Games

Card Games are an issue in the community as they are illegal from a gambling perspective but also important to note because they are breaking the GN rules of Social distancing and groups greater than 5 who are not from the same household.

After discussion the Council decided to publicly state that Card Games are banned during the remainder of COVID-19.

d. Food from non-commercial kitchens

Selling baked goods/food from a person's own homes does not follow the sanitization guidelines.

After discussion, Councillors have decided to make a public announcement to discourage selling baked goods during the remainder of COVID-19.

e. Director of Healthy Living Report on programs

The presentation by the Director of Healthy Living is post-phoned until the next meeting of Council on the 18th.

f. Letter from Government of Nunavut; Construction

Councillors Wilfred Wilcox and Sandi Gillis have both declared conflict of interest and left the call.

A request from the Government of Nunavut in the form of a letter was made to Council to determine whether the Council would support a construction season for projects that were on the GN critical construction projects for

2020. The projects that are on the critical list include Arctic College, the Elementary school upgrade and the Housing Corporation 5-Plex. The CPHO will dictate that all persons coming in from construction will have to go through the mandatory 14 days of isolation at an approved facility and that they follow all rules of social distancing and self-isolation except from work. The Council discussed the importance of these construction projects going on in the community and also the risk of bringing workers in from the south. It was noted that many communities across Nunavut believe the construction is important and support construction workers coming in with the rules of the Chief Public Health Officer.

Councillors stated they supported the construction projects but were concerned about them at the same time. They would support the project if the Chief Public Health Officer stipulated the approval and the rules of engagement under a COVID-19 environment. A letter will be written to the GN in response.
