#### g. Councillor Mohammed

- a. There is contaminated soil being stored by the sewage lagoon area. This is unacceptable and he would like administration to look into this.
- b. Can we find out who the ramp at the shoreline belongs to and have it removed before the winter as it will have an impact on snow removal.
- c. Would like to see what is going on with the quarry on the right of airport when you're driving out. Were they given an extension?

# h. Mayor Ehaloak

- a. I was driving around town and realized that the cement to hold the culverts from collapsing are moved in some areas and would like Administration to look into this.
- b. Work has been started on the bridge and people have been commenting and sending messages and asking when it will be complete. I have informed them that the fresh water bridge will be move to the Baillie Bridge and the Baillie Bridge will be removed. I have been getting comments about the Baillie Bridge to ask if this can be moved to the creek towards Lady Pelly or the creek towards Starvation Cove. There has been some comments so we would like to bring this to your attention.
- c. Attended FCM meetings and there was three days of policy meetings. The FCM staff have developed new policies. These will be reviewed again and then brought up in January at the Federal meeting.
- d. Went to Elections Nunavut office today and picked up a package for candidacy for the upcoming MLA Election. Seeking a motion to approve Leave of Absence from Council for the month of October and leave without pay to participate in the 2017 Election.
